## Section 4: FIRST AID MEASURES

### Description of necessary first aid measures

- Inhalation:** *Immediate and delayed symptoms* - IF INHALED: Remove person to fresh air and keep comfortable for breathing. Immediately call a POISON CENTER.
- Skin contact:** *Immediate and delayed symptoms* - IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower. Wash contaminated clothing before reuse. Immediately call a POISON CENTER.
- Eye Contact:** *Immediate symptoms* – IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Immediately call a POISON CENTER. *Delayed symptoms* – Proceed as with immediate symptoms.
- Ingestion:** *Immediate and delayed symptoms* - IF SWALLOWED: Rinse mouth. Do NOT induce vomiting. Immediately call a POISON CENTER.

**First Aid Facilities:** Eye wash station or treatment recommended.

**Symptoms caused by exposure:** No expected acute, delayed or aggravated conditions or symptoms from exposure to mixture.

**Medical attention and special treatment:** Treat symptomatically. No testing or monitoring for delayed effect required.

## Section 5: FIRE FIGHTING MEASURES

**Suitable Extinguishing equipment:** *Suitable-* Use dry chemical, CO<sub>2</sub>, water spray or “alcohol” foam.  
*Unsuitable-* High volume jet water.

**Specific hazards arising from the chemical:** *Formulation is non-flammable and will boil until evaporated.*

**Special protective equipment and precautions for fire fighters:** Keep containers cool with water spray. Firefighters should wear self-contained breathing apparatus and full fire-fighting turn-out gear and eye protection.

## Section 6: ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures:** Eyeglasses/ goggles, gloves and full protective clothing recommended to prevent eye and skin contact. Ensure sufficient ventilation. Area should be roped off to prevent slips and falls.

**Environmental Precautions:** Prevent runoff from entering drains, sewers, surface and ground water.

**Methods and materials for containment and cleaning up:** Cap or plug leaking containers. Cover all drains. Contain spill with absorbent material, such as towelling, sand, vermiculite or other inert material. Collect and dispose of clean up material according to local regulations. Wash away remnants with copious amounts of cold water to sewer. Clean area by working from the periphery to the centre of spill or from the edge of the room to the centre. See Section 13 for disposal considerations.

## Section 7: HANDLING AND STORAGE

**Precautions for safe handling:** Before use carefully read the product label. Contact distributor or manufacture for advice when using this product for any application other than outlined on the label or technical bulletin. Use of safe work practices are recommended to avoid eye contact and spills. Observe good personal hygiene, including washing hands after use and before eating. Remove contaminated clothing and protective equipment before entering eating area. Prohibit eating, drinking and smoking in contaminated area (eg. If container is damaged). Ensure adequate ventilation. Keep out of reach of children. Keep away from heat, sparks, open flame and direct sunlight. Do not pierce any part of the container.

**Conditions for safe storage, including any incompatibilities:** Store in cool, dry, well-ventilated area, removed from oxidizing agents, acids and foodstuffs. Ensure containers are adequately labeled and protected from physical damage when not in use. Do not store at temperatures above 109°F (42.7°C).
